Sound Access Park Boat – Trailer Storage Policy:

South Sound Access: No boat or trailer shall be stored at the South Sound Access unless the boat can be launched from the Access consistent with the published Sound Access Policies. This site is suitable for day sailors, kayaks, and canoes. The only trailers permitted at the South Sound Access are those for watercraft being used at the Access and shall be roadworthy and properly registered by an appropriate State agency. No trailers can be stored at the South Sound Access unless the boat is in use at, or moored at, the Access. The storage of trailers for boats larger than those that can be launched at the Access is not permitted.

North Sound Access: North Sound Access storage is for kayaks, paddleboards, and canoes only. Boat trailer storage is not allowed at the North Sound Access.

Registration Stickers must be affixed to the registered Water Equipment.

I represent that I have registered all my water equipment as required by the VNPOA policy and am aware of the Sound Access Park Policies of the VNPOA.

I further agree that the VNHPOA shall not be liable, and hereby waive any potential claims against the VNHPOA, for any act, events, or occurrences which may arise from my storage or use of my water equipment at either Sound Access Park.

I further agree that the VNHPOA shall not be liable and hereby waive any potential claims against the VNHPOA, which may arise for any loss or damage to my water equipment for any reason, including but not limited to theft or vandalism.

I hereby take responsibility for the security of my Water Equipment and will use locks and cables to secure my Water Equipment.

I further understand and agree that the VNHPOA will monitor the storage racks for expired registration decals to ensure that unregistered or abandoned water equipment does not accumulate and take up available rack or other storage space; and that the VNHPOA may, after exercising reasonable efforts to contact me using the information I have supplied on my registration form, remove and dispose of my water equipment.

I hereby understand that the registration process covers three (3) years and is renewable every three (3) years.
